Mutton Bustin' Rules

Mutton Bustin' takes place during the Rodeo performances on Saturday, April 30th, and Sunday, May 1st, 2011. **Contestants must arrive and check-in by 10AM.** The announcer will call for the Mutton Busters to report behind the chutes at some time during the Rodeo. Only parents or guardians will be allowed behind the chutes with the contestants.

Contestants must weigh **less than 55 lbs (with clothes on)**, and be between **4 and 7 years of age**. Weight and age limits will be strictly enforced.

BOTH parents (or legal guardians) must sign the attached Release & Waiver and mail with Entry form and fee to: **Coarsegold Rodeo, PO Box 952, Coarsegold, CA 93614**, no later than April 22, 2011.

10 riders will compete each day for a total of 20 contestants. Entries will be taken in the order they are received up to April 22, 2011. After entries close you will be notified which day to compete.

Entry fee is **\$25** which includes two tickets to the Rodeo performance. **Check in at the MAIN Ticket Entrance when you arrive** to receive your contestant tickets.

A silver buckle will be awarded to the winner each day, with prizes for each contestant. This is a judged event. Each contestant will receive points for their ride by a judge. The judge's decision is final. In case of a tie, a coin toss will decide the winner.

Helmets and vests will be available, or bring your own.

In consideration of my participation in events organized or sponsored by **Tom & Kristi Bohna, DBA Bohna Arena, and CRA**, we waive, release and discharge **Tom & Kristi Bohna, DBA Bohna Arena, CRA**, their owners, directors, officers, agents, volunteers and members, their representatives, heirs, executors and assigns from any and all claims of liability for injury or damage to myself, my animals or my property arising out of my participation. This agreement is binding upon my executors, heirs and assigns.

We expressly waive any rights we may have under California Civil Code 1542, which states, "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him/her might have materially affected his/her settlement with the debtor."

We agree that we will indemnify and hold harmless **Tom & Kristi Bohna, DBA Bohna Arena, and CRA** their owners, officers, directors, volunteers, members and agents against all claims, demands, and causes of action, including court costs and actual attorney fees, arising from any proceeding or lawsuits brought by or prosecuted for my benefit, in which this release is upheld.

Tom & Kristi Bohna, DBA Bohna Arena, and CRA, its agents, volunteers or employees shall not be liable for any damage which may accrue from any cause or result or result of fire, theft, running away, state of health, injury to person, horse or property.

The undersigned has full power, authority, authority, capacity and right without limitation to execute, deliver, and perform this release. We fully understand that any modifications, additions and/or deletions by myself to this release does not alter the express intent of this release.

We acknowledge that we have read this Release of Liability and know and understand its contents.
